

**Town of Mountain Village and State of Colorado Liquor Enforcement Division
Fee Schedule Effective 07/02/2010**

2. New applicants owning 10% or more of a business and New Managers must go to Town of Mountain Village Police Station to get fingerprinted and have a background check done by the Colorado Bureau of Investigation (CBI). Each person will need: \$5.00 cash or check made out to Town of Mountain Village for fingerprints, and a separate check made out to Colorado Bureau of Investigation for \$38.50. CBI check must be either a business check or a money order (no personal checks will be accepted). If you live out of State call Mountain Village Police Station (970)728-9281 for fingerprint cards and instructions to be sent to you.

2. Below is an example of how to calculate your costs for a new Liquor License – i.e. New Application for Hotel and Restaurant Liquor License, with *concurrent review, and New Manager Registration:

*Concurrent review: after your completed application and checks are submitted to the Mountain Village Town Clerk, she/he will date stamp them and send the original application and check for the State fees to the Colorado Liquor Enforcement Division, the same day (or next business day). When the application is received by the Liquor Enforcement Division they will start the review process thus saving processing time.

Without concurrent review the application and checks will be held by the Mountain Village Town Clerk for the applicable 30 day noticing period of public hearing. If Town Council (acting as the local liquor licensing authority) approves the application at said hearing, the application and check for state fees will be sent to the Colorado Liquor Enforcement Division for review, at present the state review time for applications without concurrent review is approximately 30 to 60 days after receipt of paperwork.
