1. I am applying to the Town's 2018 Defensible Space Incentive Program for a rebate of the costs associated with the creation of defensible space on my property. I understand that I am eligible to receive a rebate in the amount of 50% of my costs up to \$5,000 through this program. I understand that the town will send me a Federal 1099 form if the rebate amount is over \$600.
2. I agree that I am a property owner in Mountain Village and the defensible space created on my property was performed by a licensed and insured contractor and was consistent with the town's Wildfire Mitigation/Defensible Space permit regulations and guidelines contained in the Town of Mountain Village Community Development Code Section 17.6.1., Fire Mitigation and Forestry Management. A copy of the Town Forester's Scope of Work, Final Approved Permit and Sign off, and proof of payment is attached.
3. I agree, in good faith, to implement the attached additional wildfire mitigation procedures recommended by the West Regional Wildfire Council on my property to further reduce my wildfire risk.

**ADDITIONAL WILDFIRE MITIGATION RECOMMENDATIONS  
PREPARED BY WEST REGION WILDFIRE COUNCIL  
TO FURTHER REDUCE WILDFIRE RISK**

\_\_\_\_\_ I have moved my firewood pile or certify that my firewood pile is more than 30 feet away from my home.

\_\_\_\_\_ I have cleared flammable debris from my gutters and roof or certify that my gutters or roof are clear of flammable debris.

\_\_\_\_\_ I have mowed or trimmed grass to a height of six inches or less for at least the first 15 feet surrounding my house.

\_\_\_\_\_ I have raked/removed pine needles and other flammable debris away from my structure.

\_\_\_\_\_ I have removed flammable material from underneath any elevated decking on my home.

\_\_\_\_\_ I agree to maintain my defensible space/fuels reduction project and regularly address these items.

\_\_\_\_\_ I will evaluate and potentially upgrade the "ignition resistance" of the exterior materials of my home, including decking, siding, and roofing materials.
