- Agenda Item 4A- 2019 Green Team Budget:
 - **NEXT STEPS:** Discussion took place and the Green Team Committee **DIRECTED** Kim Montgomery to update the 2019 Green Team Budget as discussed during the meeting. EcoAction Partners 2019 Fee-for-Services Contract/Funding

EcoAction Partners mission is to track regional GHG emissions and coordinate programs that reduce energy and waste.

EcoAction Partners, previously named The New Community Coalition, was formed in 2007 by and for the governments of Telluride, Mountain Village & San Miguel County to serve as a central sustainability organization for our region and to coordinate and communicate on sustainability programs. In 2010, a grant awarded to EcoAction Partners to work with the University of Colorado at Denver Center for Sustainable Infrastructure Systems guided the development of a comprehensive GHG Inventory baseline report for San Miguel and Ouray Counties. Since then, EcoAction Partners updates the report annually and performs further analysis of energy use and emissions factors at both regional and local levels. This information is presented annually to the government and community to show how we are making progress toward our goal. Additionally, EcoAction Partners provides regional community programs targeted to specifically reduce energy and waste. EcoAction Partners reports on the measurable outcomes of these programs.

Mountain Village has been a solid partner with EcoAction Partners since inception. The table below demonstrates Mountain Village funding over the previous years.

EcoAction Partners provides programs and services that are utilized by Mountain Village residents and businesses, as well as GHG analysis and technical assistance directly to MV staff and council. In addition, many of EcoAction Partners Services are shared and funded regionally, as noted in the attached proposal.

For 2019 funding EcoAction Partners applied for a Town of MV Grant in the amount of \$6,746. The MV Grant was for funding a portion of regional community programs that are available to and help Mountain Village residents, as well as MV specific services. Funding was requested for:

- Administration of the SMPA Income Qualified Weatherization Program, which has served (13) MV residents, (8) in 2018.
- Greenlights LED Program coordination
- Truth or Dare School Program and TSD energy and waste efforts
- Electronics Recycling
- The Carbon Neutral Coalition
- Proposed monthly (or bi-monthly) "Energy Wise" Green Team Tip

Unfortunately the Mountain Village Grant was declined.

EcoAction Partners also proposed an expanded contract for services to TMVOA to help Mountain Village businesses in the amount of \$5,190 (beyond the Recycling and Trash sorting services that EcoAction Partners provides at the Sunset Concert Series). The proposed new services included:

- Green Business Certification, as well as C-PACE education & promotion
- Property Manager Training Program
- Business Community Composting Planning & Consulting & Research

Unfortunately this contract was also declined.

EcoAction Partners has been notified that Mountain Village Town Council has requested a reduction in EcoAction Partners proposed 2019 Mountain Village Contract for Services. Thus, a slightly revised proposal is below, for further discussion at the Green Team meeting. EcoAction Partners wishes to continue to provide successful programs for the MV community, in addition to technical greenhouse gas and energy reduction analysis to the MV town staff and council. Thus, in 2018, EcoAction Partners continued to provide services beyond the MV grant allocation, in order to continue to engage the Mountain Village community in programs that reduce energy and waste. We propose the services itemized below in order to continue our partnership with Mountain Village, working toward our shared goal to reduce GHG emissions, energy use, and waste.

*EcoAction Partners rate for services varies based on several factors, including type of service provided, personnel involved, and whether the service provided is shared among regional partners or jurisdiction-specific.

Additional explanations of the proposed services follow:

- A. **EcoAction Partners Broad-Spectrum Services:** EcoAction provides the following resources, most of which would not exist in our region if our organization did not exist. They are:
 - Energy efficiency programs
 - Website resources
 - o Monthly newsletters and updates
 - o GHG data, collected since 2010, and available online this coming year
 - Overall GHG reduction efforts for the community
 - Educational programs
 - o Forums, meetings, and other energy related events and services
 - o An umbrella organization for other related programs
- B. Mountain Village Community GHG Inventory, Energy Analysis & Presentations: Using the regional GHG Inventory based on the Global Greenhouse Gas protocol and methodologies, EcoAction Partners is currently in-process of developing the Town of Mountain Village community-specific GHG inventory from 2017 data which is inclusive of government, businesses, residents and visitors. This inventory allows analysis of the GHG emissions of the broader Mountain Village Community, to help Mountain Village Green Team, staff and council understand where the Town of Mountain Village stands as compared to the whole. This data tracks with the municipal boundary of the town and town facilities and allows analysis of GHG, electricity and natural gas emissions from year to year. The analysis assists Mountain Village with prioritizing and addressing key GHG emission sources.
- C. Regional GHG Inventory: In addition to the Town of Mountain Village GHG report, EcoAction Partners collects, records and presents on the GHG Emissions for the Ouray and San Miguel County region, as well as just the SMC GHG emissions as a service for San Miguel County. This GHG Inventory was developed through a grant program with the University of Colorado at Denver as an instrument to create a baseline, track and thus help reduce regional GHG emissions. Regional reporting supports the regional governments' adoption of the goal to reduce GHG emissions 20% by 2020 from a 2010 baseline. This regional work includes analysis of variations from year to year, improving on data and calculations, and in-depth work currently being completed to update methodologies to comply with the most recent Greenhouse Gas Protocol for Cities.

- D. **Suggestions for Mountain Village community GHG reductions:** Along with the annual Mountain Village GHG Inventory and Energy Use Analysis presentation, EcoAction Partners works with town staff to provide specific top suggestions on ways to reduce the Mountain Village community's GHG emissions. Analysis of the positive impact of adopting specific recommendations is provided as feasible to the Town of MV Green Team, Council and staff.
- E. Assistance to Energy Action Coordinator (Michelle Haynes) on Analysis of Governmental Energy Use and Special Projects: As requested, EcoAction Partners will provide input, guidance, or further analysis on anomalies related to government energy use data, and Special Projects. Examples of Special Projects include:
 - a) Government efficiency, renewable energy & offset project consulting as needed
 - b) Update Gondola GHG offset calculation
 - c) Farm to Table Program: EcoAction Partners will calculate GHG emissions savings
 - d) Sunset Concert Series plastic cup recycling recommendations (#5 vs. #7)
 - e) MV Waste contract data: Analyze & utilize collected data
 - f) Regional calculation of the GHG benefits related to local affordable housing
- F. Mountain Village Green Team: EcoAction Partners is pleased to attend MV Green Team meetings to share regional programs, perspective, and efforts, and provide input and guidance to the Green Team. EcoAction Partners offers the Green Team experiential expertise and can assist with prioritizing programs to maximize GHG reduction for the town.

Additionally, the MV Green Team has requested specific assistance on the following:

- a) Assistance on the MV Composting Incentive Program, which includes assistance to MV staff by providing information for implementation of this incentive program, as well as assistance to applicants (reduced to up to 3) to ensure successful MV composting projects
- b) GHG Analysis of all existing MV incentive programs
- c) MV specific study on GHG emission comparison between snowmelt systems and shoveling / hauling
- **G. Sneffels Energy Board:** The Sneffels Energy Board is an EcoAction Partners original program that formed to support a 2010-2013 grant provided by the previous Colorado Governor's Energy Office. This group meets quarterly to share information and experiences, participate in regional programs, and identify new opportunities. Regional leaders from San Miguel County, and all jurisdictions within SMC (Telluride, Mountain Village, Ophir, Norwood), along with Ouray

County, and all jurisdictions within Ouray County (City of Ouray, Ridgway, and greater Ouray County), as well as SMPA and community groups (ROCC) participate and collaborate on setting and accomplishing sustainability goals, and share efforts and progress toward reducing GHG emissions. Advantages of this regional approach include a stronger voice to influence political change, greater leverage for grants, the ability to address regional challenges together, such as the 5% cap on SMPA locally produced renewable energy that Tri-State implements, and the sharing of best practices.

Since inception, a Mountain Village Town Council member and MV staff participate in the quarterly Sneffels Energy Board meetings, and to learn about new energy efficiency opportunities, to collaborate regionally with other jurisdictions on projects and programs focused on GHG emissions reduction, and to report back to Town Council and staff from the Sneffels Energy Board meetings.

Promote SMPA & Black Hills Natural Gas Rebates and Alpine Bank Energy Loan Program: EcoAction Partners promotes SMPA and Black Hills Natural Gas Rebates that are offered to all SMPA members and Black Hills customers as a helpful way for residents and businesses to save money through making energy efficiency improvements. For those that need a financing tool for larger scale improvements, EcoAction Partners worked with Alpine bank to develop the Alpine Energy Loan Program, which offers a way for residents to finance energy efficiency and renewable energy improvements.

Colorado Department of Health and Environment (CDPHE) Recycling Rebates Economic Opportunity (RREO) Information & Grants: EcoAction Partners holds a seat on the CDPHE Pollution Prevention Advisory Board Assistance Committee, which advises on directing RREO grant & rebate funding for the state. Additionally, the bi-monthly conference calls provide valuable information about the recycling industry from a national and statewide perspective. Successful programs and projects on waste reduction are also shared, many from grant projects that have been funded. Ecoaction Partners brings the numerous grant and funding opportunities to our region through the Sneffels Energy Board.

H. **Building Energy Code Updates:** Continue to provide information and assistance to the Mountain Village Planning and Building Department and other regional building departments as needed for updating the Building Energy Code to the 2018 International Energy Conservation Code with appropriate amendments for our climate and building environment. We are working

toward all regional jurisdictions being on same code with the necessary energy code amendments to maintain progressive energy code. EcoAction Partners will coordinate training opportunities through the State of CO for building departments, contractors, architects, & rest of building community, on an as needed and available basis.

Update REMP calculations: Mountain Village's Renewable Energy Mitigation Program (REMP) will be updated in consistency with current energy mitigation costs and updating calculations for other jurisdictions. The updated energy mitigation fee calculations address exterior energy use – snowmelt systems, heated garages, outdoor pools & spas, and more. Additional modification services will be available as needed for additional negotiable cost, such as adding a community solar array option if and when that becomes available, and the analysis of best practices for snowmelt systems. Additionally, if REMP calculations are needed for a specific building project, EcoAction Partners can and will provide this service.

- I. OPTIONAL: Mountain Village REMP Green Project Grant Program (\$25,000-\$50,000): EcoAction Partners could operate the REMP Green Project Grant Program for the Mountain Village Community, with funding amount as allocated by Michelle from the REMP budget. The goal will be to maximize GHG savings resulting from granting of funding (typical return of up to 10:1), through leveraging other available funding and prioritizing energy efficiency. This program will be ongoing, with a specific annual application timeframe, and a deadline for project implementation as agreed upon by the Mountain Village Green Team. It is recommended that this committee consists of 1 each (MV Green Team, MV Town Council member, MV Town staff, and 1 community member) or as determined by the town, who will approve grant applications, communicate to MV Green Team & Town Council, and guide EcoAP staff. Of the TEMP funds allocated, 88% would go directly toward awarding grant projects, and 12% would be allocated to EcoAP to cover grantee assistance in calculating energy/GHG savings, coordination of grant review with the committee, administration and monitoring services. Results from the 2015 SMC Green Grants Program available upon request.
- J. **NEW SMPA Community Solar Farm (pending)**: EcoAP is working with SMPA to gather support and the efforts needed to implement the development of a new SMPA community solar array, which would then be available as an option for REMP and for other community members to purchase.

K. **Greenlights LED Program:** Encouraging residents and businesses to switch to LED lighting by providing a combined rebate from SMPA (50%) and government (25%) for up to 75% off the purchase of new LED bulbs. Each government commits a "matching" portion.
