### DELIVERY PERMIT: RULES

- ~ To qualify for consideration of delivery permit, you must have a Mountain Village business license
- ~ Parking in designated Zones while actively loading/unloading
- ~ Permit is not intended for long term parking anywhere
- ~ Permit does not allow free parking in any pay lot
- ~ Permits are issued by MVPD, with an administration fee of \$20 per year from date of issue.
- ~ Display permit in lower left corner of windshield
- ~ Usage is based on first come first serve access
- ~ Misuse of delivery permit will result in loss of permit
- ~ All delivery vehicles must carry liability insurance
- ~ For assistance with deliveries in the core, contact Plaza Services 729-3458
- ~ For other questions contact Code enforcement 729-3455

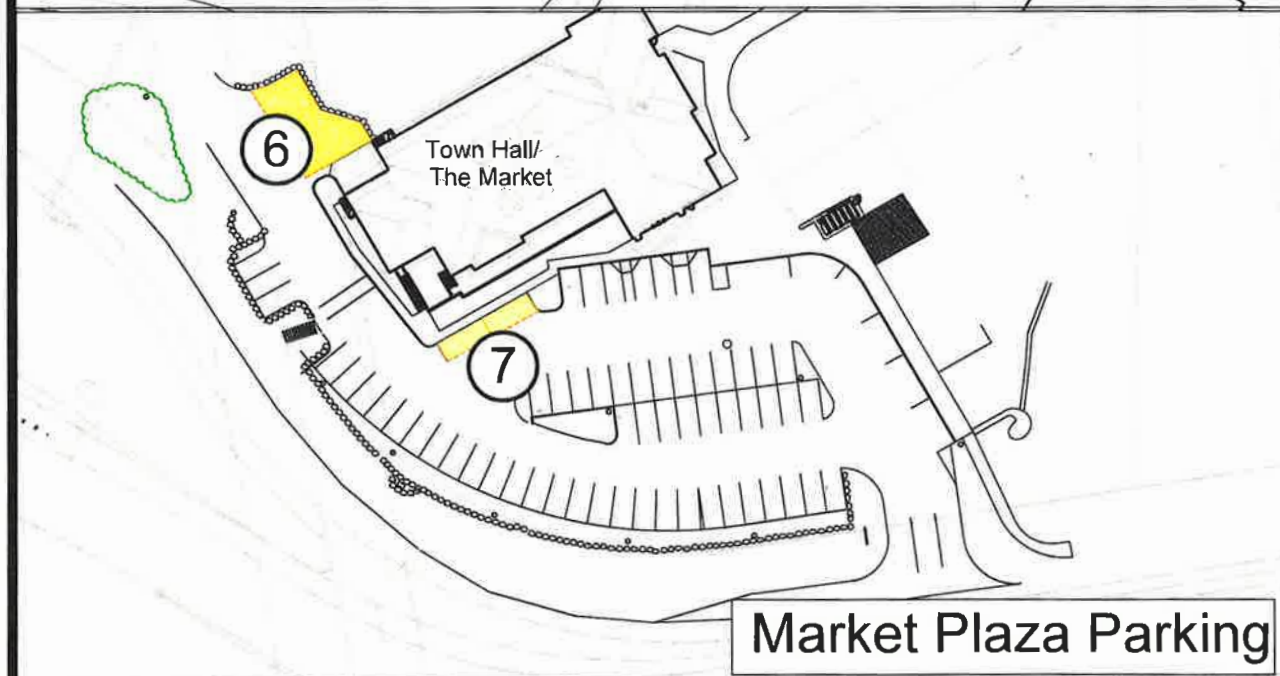
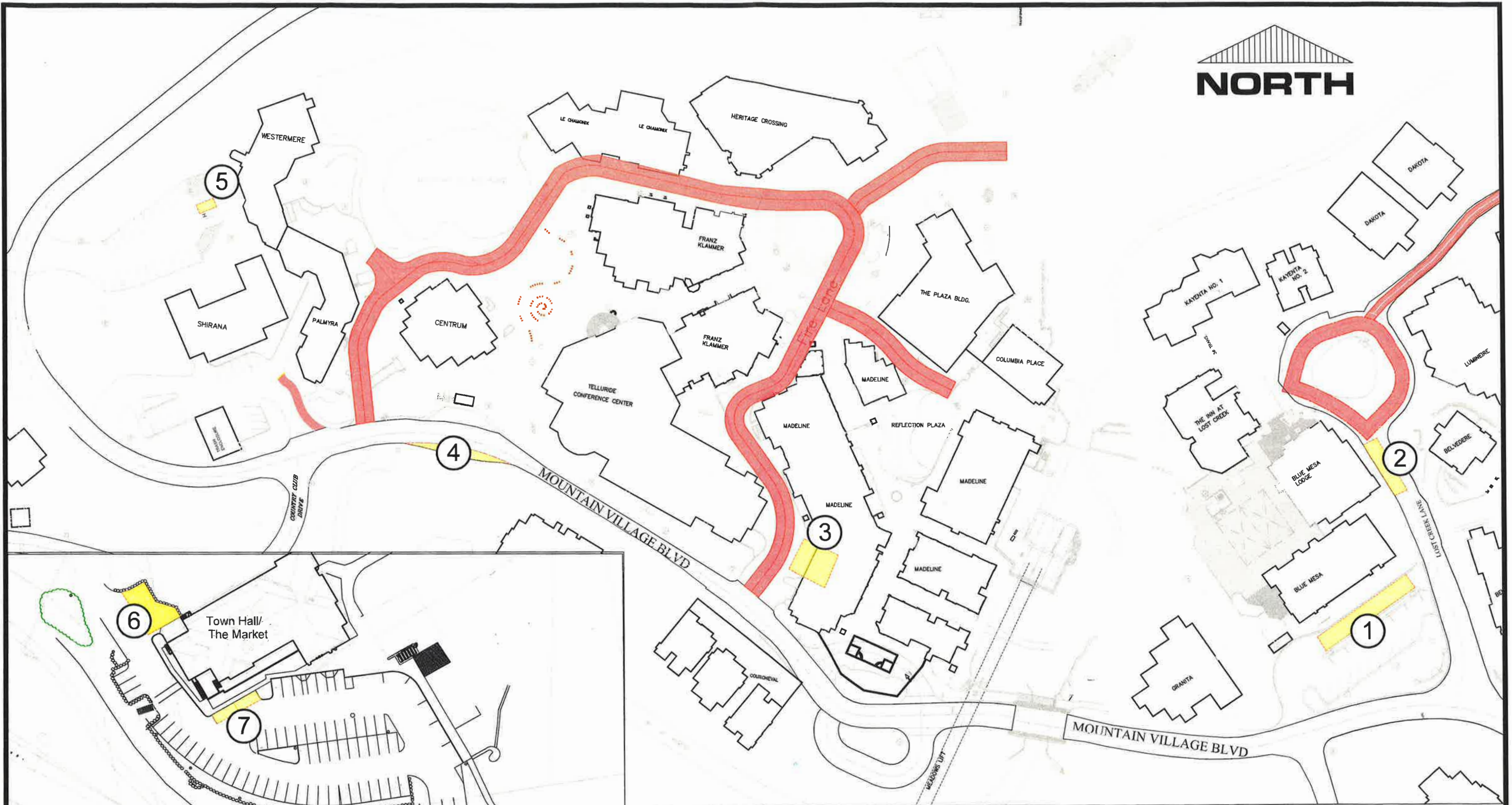
