[Mountain Bucks Research]

At the November BDAC Meeting, staff was directed to research into the existing safety bucks / mountain buck program and provide additional information for BDAC to include options for a rebranding of this program.

Goal: Buying local has immediate positive influence. Through this program a hope would be to enhance our local communities ongoing vitality by creating incentives for local residents and businesses that will help increase resident and business spending within the Mountain Village. COVID-19 has prioritized the need for local business support and assistance through incentives to shop local through the Holiday Season and into 2021.

History: Mountain Bucks were established as a way to help local business. In the past, technical problems have limited businesses involvement in the program to a point where it was no longer a priority. Additionally, there were accounting issues with the program that made it difficult to track for reimbursement. Separately, the Town and Town employees participate in a program called "Safety Bucks" which is associated with the Safety Committee and workman comp claims. If there are no claims, then the departments receive these safety bucks.

The issuance of paper certificates has been the most difficult issue this program has faced. Problems related to unauthorized modifications of the certificates has created trust issues in the program from businesses, and the inability to receive change is problematic for buck users. Successful programs detailed below have eliminated the paper certificates and have replaced them with gift cards or receipt reimbursements. Based on research into these programs – staff does not recommend pursuing a reimbursement program due to staffing and tracking issues.

Other Community Programs:

Montrose, Colorado: Montrose Bucks

Montrose Bucks are coordinated by the Office of Business and Tourism to provide extra incentives for the community to shop locally and support local merchants. Bucks can be given as gifts, rewards, and incentives by individuals and businesses alike - year-round.

Spend \$50 dollars and receive \$60 dollars in Montrose Bucks. There is a limit of \$400 per family (which equates to \$480 in Montrose Bucks. They are chain or store specific.

Craig, Colorado: Spree Bucks

Shop at a city sales tax licensed business in Craig between Nov. 23 and Nov. 30, keep the receipts, and take them to the Chamber by Dec. 7 to receive free Spree Dollars. Earn \$5 in Spree Dollars for every \$50 spent and up to \$30 in free Spree Dollars per individual. Special Spree Dollars must be spent locally by Dec. 22. A total of \$15,000 dollars in rebates are available. Only purchases of goods eligible for city sales tax count, and tobacco, gasoline, utilities, and pharmaceuticals do not qualify for the rebate.

Boulder, Colorado: Retail SOS

The Retail S.O.S. program provides for the purchase of Boulder e-gift cards valid at participating local retailers. More than 60 Boulder retailers have signed up for the program and are being activated on the gift card website this week. Purchasers will receive a free \$25 Boulder Bonus Bucks card for every \$25 spent in Boulder gift cards purchased, up to \$100 per person, as a free incentive for the purchaser. (Limit of four \$25 Boulder Bonus Bucks cards per purchaser). Please visit the Boulder Gift Card web portal for participating retailers, gift card purchases and Boulder Bonus Bucks and program details.

The city will use a portion of allocated federal CARES Act funding to pay for the matching Bonus Bucks cards, which will be valid at participating retailers through Dec. 30, 2020, the deadline for when CARES Act funds must be spent.

She confirmed that they are providing administrative help in distributing the grants monies. It seemed like given our current relationship with our business owners and the limited number of businesses that we have it may be better that we maintain control of this process. Let me know your thoughts if you feel otherwise. She also said she works with the state tourism board and would love to help get the word out more about the work we are doing and I suggested she connect with our marketing department to coordinate.

"A few years ago, the brewery would not have considered a Mountain Village location, Thacher says, but things there have changed dramatically. Not only is there a healthier mix of tourists and locals, but the town (Mountain Village is actually its own town, separate from Telluride) invested in upgrades and changes. "They spent a ton of money...they refurbished the gondola...and the whole plaza is heated underneath," the brewer notes.

Not only that, but the entirety of the town's Village Center is a state-approved "<u>common</u> <u>consumption area</u>," where customers of various bars and restaurants can buy alcoholic beverages and walk around with them. That will come in handy this year in particular, during the coronavirus pandemic, as bars, restaurants and breweries can only seat a very limited number of people. In the common consumption area, however, there are plazas and tables and benches, and "there are fire pits everywhere. People really enjoy being outside," Thacher says. In fact, "the whole thing was sort of made for" a pandemic, he adds. The town has even repurposed a few gondolas as dining cabins that serve all of the bars and restaurants in the common consumption area."

Good afternoon Managers:

Last week, Gov. Jared Polis signed the **Small Business Relief Program** into law. The bill provides \$57 million in direct aid, grants, and annual fee waivers to struggling small businesses and creates grant programs and allocates funds specifically for art and cultural organizations as well as minority-owned businesses.

Multiple state agencies are working with local government associations and governments on the implementation of the new program including eligibility, applications and distribution.

Provisions in the enacted legislation allow municipalities that are in compliance with state public health orders to apply for grant funding if the municipality resides in an ineligible county or if the county decides not to participate in the program. The deadline to apply for grant funding through the DOLA Division of Local Government Grant Portal is on Jan. 8, 2021.

Because the window to apply for this grant funding is so narrow, CML has created a **SB 20B-001 resource page** on our website to help provide the most up-to-date information available.

CML will continue to keep our membership informed as state agencies move forward in implementing this new law. If you have any additional questions, please feel free to reach out to **Morgan Cullen** directly.

COVID-19 Relief for Small and Minority-Owned Businesses and Arts Organizations (SB 20B-001)

Home > Topics & Key Issues > Coronavirus (COVID-19) > COVID-19 Relief for Small and Minority-Owned Businesses and Arts Organizations (SB 20B-001)

COVID-19 Relief for Small and Minority-Owned Businesses and Arts Organizations (**SB 20B-001**) provides direct relief to:

- Small businesses (\$37 million)
- Arts and cultural organizations (\$7.5 million)
- Minority-owned businesses (\$4 million).

It also provides state assistance to support a one-year suspension of health inspection and liquor licensing fees. All small businesses with annual receipts of less than \$2.5 million in calendar year 2019 are eligible for relief through the program.

Counties that are under severe capacity restrictions as determined by a public health order and that are in compliance with the order must develop a process to accept applications from small businesses for relief funding. DOLA is required to allocate funding to counties based on the population of the eligible local governments. Both DOLA and participating local governments can be compensated for administrative costs associated with overseeing the program.

The legislation has been amended to allow the participation of small businesses located in municipalities that are in compliance with state public health requirements even if the county where the municipality is located is not eligible to participate. In addition, the legislation sets forth a process for municipalities to work with counties to get assistance to small businesses out as quickly as possible.

A number of municipalities have suggested that additional language is needed to ensure municipally-owned and operated performing arts and cultural centers are eligible for funding. CML has raised this concern several times with each of the house and senate bill sponsors. We have been assured that these municipalities are indeed eligible.
