TOWN OF MOUNTAIN VILLAGE DEFENSIBLE SPACE INCENTIVE PROGRAM GRANT APPLICATION 2021



SUMMARY:

We want to help you create defensible space on your property to lower your property's wildfire risk. In 2021 we have updated our Wildfire Mitigation Incentive Program with TMVOA as funding partners. Through this program, we will reimburse you 50% of the total defensible space project cost up to \$10,000 per property.

This incentive program is open until funds are exhausted and is for existing Mountain Village homes. Homes under construction do not qualify for this program.

STEPS TO COMPLETE YOUR APPLICATION:

- 1. Schedule a home site visit with the Town of Mountain Village's staff forester, Michael Otto. Due to snow accumulation, site visits are generally scheduled from April 1st to Oct 31st. To schedule a home site visit, fill out the online form on the Town of Mountain Village wildfire mitigation page or contact Michael Otto at (970)708-4358, (970) 369-8103, or motto@mtnvillage.org.
- 2. The staff forester will provide a detailed scope of work summary, detailed map of the project area, and at least three pictures of the project area.
- 3. Use the scope of work summary and detailed map of the project area provided by the staff forester to obtain project bids from at least three different contractors. Bids should provide **cost/acre**. A local contractor list is available here or on the Town of Mountain Village Wildfire Mitigation page.
- 4. Fill out and turn in your application to the Town of Mountain Village staff forester. Please mail or drop off at 455 Mountain Village Blvd Ste A, Town of Mountain Village, CO 81435 or email application to motto@mtnvillage.org. The staff forester will attach the scope of work summary, detailed map, and pictures to the application.
- 5. After review and approval of your application by the Town of Mountain Village staff forester, a tree permit will be issued to the contractor of your choice. Your contractor can arrange a tree removal permit site visit by contacting the staff forester. After a tree removal permit has been issued, the wildfire mitigation project to be conducted by your chosen contractor can commence.
- 6. After completion of the project, the Wildfire Mitigation Incentive Program rebate <u>form</u> must be completed and submitted to the Town of Mountain Village staff forester. Please mail or drop off at 455 Mountain Village Blvd Ste A, Town of Mountain Village, CO 81435 or email application to moto@mtnvillage.org
- 7. Following a review of the completed project by the staff forester, the Town of Mountain Village will issue a rebate mailed to the applicant's address.
