Compliance with liquor laws and rules can be complicated and involve serious consequences if not followed. Mostly, improper service of alcohol could lead to serious bodily injury or death. Alcohol Beverage Training classes are State of Colorado approved and qualify for the responsible vendor training Act – Found in Section 44-3-1001, C.R.S. and Regulation 47-605, 1 C.C.R. 203-2.

The training course is 2+ hour and will provide you the needed information to successfully pass the Responsible Vendor Training Program in Colorado for on and off-premises liquor-licensed establishments. Participants will have to take an exam at the end of the class on your cellular device and score a minimum of 70% in order to pass and receive a certification.

- To designate your business as a Responsible Vendor, all staff who handle alcohol need to be currently certified and all new employees certified within the first 90 days of employment to qualify.
- This certification covers the statutory mandates for all employees, managers, and owners.
- Licensees designated as Responsible Vendors; this fact shall be considered when applying a penalty for any violations.
- This is an excellent opportunity to have your employees trained on their responsibility and liabilities in serving alcohol, educating your employees on the tools and techniques necessary to recognize signs of intoxication and over service of patrons.
- This is also a good time to network with others in your business!
- You will learn how to stay compliant with State and Local regulations.
- Learn to protect your place of business from alcohol liability lawsuits and penalties for alcohol violations.
- Learn improved customer service and satisfaction with increased staff professionalism.
